In consideration of the promises and statements to follow herein, New Hope Rescue Inc. (Rescuer), a Colorado non-profit, and the undersigned (Adopter), having read and in full understanding, do willingly enter this agreement with the intent to be legally bound by this agreement and hereby consent and agree to the following: The Adopter hereby understands, promises, and agrees, whereupon receiving the animal to indemnify, forever release, discharge and hold harmless Rescuer from any and all actions, causes of action, suits, debts, duties, claims and demands resulting from any action or omission arising out of any cause whatsoever and without limitation and particularly as related to the adoption of:

The Adopter hereby declares that neither representations about the nature of the adopted pet, nor any representations regarding the nature and extent of legal liability, or of financial responsibility have induced the adopter to sign this contract.

Rescuer acknowledges receipt of a donation in the form of an adoption fee and in the amount of \$ _____ to aid with reimbursement of veterinary and other expenses from the Adopter.

The Adopter hereby acknowledges the following provisions as defined:

Fee: The pet can be returned for a refund of all but the amount of the Compassion donation for 14 days. The adoption fee is not a sale price, but requested to defer or reimburse Rescuer for any and all medical expenses, or any other expenses incurred by the dog or Rescuer to consider the dog for adoption. _____

Health program: The Rescuer's pet, if adopted as a puppy or kitten, shall complete the DAPP series of 3 shots along with rabies. Adopter agrees to complete the shot series. All dogs must have yearly booster shots of DAPP, and the rabies vaccines. Renewal of the rabies vaccine is required by law and therefore by the terms of this contract. Adopter agrees to obtain immediate vet care for the pet should it become sick or injured and takes full financial responsibility for such care. We suggest that you take your new animal to the vet during the first two weeks after you receive your new pet, New Hope Rescue Inc. will not pay for this vet visit or any resulting treatment. _____

Important notice – Temperament: Rescuer makes no explicit or implicit guarantees in reference in the health and/or temperament of the pet. The pet is adopted "as is" and the Adopter assumes all responsibility for treatment of any and all existing conditions, or any other conditions of physical or temperament changes that may occur. Rescuer will provide the pet with the above required vaccines before adoption if the age and current health of the dog permits. While the Rescuer makes every effort to place for adoption healthy animals, the Rescuer cannot guarantee the health of any animal, and shall not be held responsible for any medical expenses which may be incurred, and is hereby expressly excluding any implied warranties of merchantability or fitness for any particular purpose, including and without limitation, any warranties regarding health or temperament, including whether the animal is housebroken. _____

(4) to safeguard the animal from loss or mishap: not allowing animals to run at-large unsupervised or expose the animal to known dangerous conditions such as aggressive animals. (5) to immediately notify New Hope Rescue Inc. and local animal control if the animal is missing. (6) to NOT give or sell the animal to another person, including relatives, rescue groups, a humane association, shelter, pound, or medical/experimental laboratory or similar organization. (7) to NOT allow an experimental laboratory or similar organization access to the animals. I understand that the animal has been/will be spayed/neutered and vaccinated by a licensed veterinarian and that the animal's health is accurately represented to the best knowledge of New Hope Rescue Inc.; however, no representations are made as to the temperament or mental disposition or health of the animal. (19) I agree to foster the animal at my own risk and to be solely responsible for any damages to people or property caused by the animal(s). I further promise and agree to indemnify and release New Hope Rescue Inc. and its officers and directors of any liability arising from any known, unknown, or unanticipated damages to people, animals or property caused by the animal(s). (20) I am fully aware of, understand, and agree to all the terms and conditions of this release and indemnification provision and that it is binding and enforceable by law.
